A Councillor shall make this declaration at or before the first meeting of the Council following election or co-option.

In either case, the Council may resolve to permit a declaration to be made at or before a later meeting fixed by the Council in the resolution.

Failure to comply shall make the office vacant.

This form is to be retained by the Parish Council, and is for use after the Council has adopted a Code of Conduct under the Local Government Act 2000. A copy is to be supplied to the relevant Monitoring Officer.
