I am writing in respect of your Parish Precept requirements for the financial year commencing 1 April 2019. Please can you complete the enclosed Precept Demand Form including the Parish Council bank account details and return the form to the above address by Friday 11th January 2019. If you envisage difficulties in submitting your form by the due date please inform me at the earliest opportunity.

Formal Notification of the formation of Somerset West and Taunton Council

Taunton Deane Borough Council and West Somerset Council would like to inform you that the Rt Hon Sajid Javid, the previous Secretary of State for Housing, Communities and Local Government, has approved their joint submission to create a single new Council.

The single new Council will be called 'Somerset West and Taunton Council'.

The single new Council will be **established on 1 April 2019** and the two extant councils (Taunton Deane Borough Council and West Somerset Council) will stand down as per the Somerset West and Taunton (Local Government Changes) Order 2018.

Arrangements for the governance and formation of the new Council are being undertaken by the Shadow Authority until Somerset West and Taunton Council comes into existence on 1 April 2019.

Payment of 2019/20 Precepts

With the formation of the new council from 1 April 2019 we have taken the opportunity to review the way precepts are paid to town and parish councils.

From 1 April 2019 any precept request which is less than £10,000 will be paid in one instalment in April 2019. Any precept request which is over £10,000 will be paid in two equal instalments one in April 2019 and one in September 2019. This arrangement will then continue for the foreseeable future.

Somerset West and Taunton Council 2019/20 Tax Base

As well as the Precept Demand Form I enclose the indicative "Band D Equivalent" table which shows the proposed Tax Base. This will be presented to the Council's Section 151 Officer for approval.

The Local Tax Base column will provide an indication of the precept that your council could levy, if applied as a multiplier, i.e. Tax Base x Precept Rate = Total Precept.

I have also enclosed a document which shows how the local tax base figure has been produced for your Parish/Town Council.

Allowance for election costs in the precept

The Town and Parish elections will be held on 2 May 2019 and you will need to allow for the costs involved when setting your precept for next year.

While some costs are shared as this will be a combined election, there are certain expenses which will fall upon the Town/Parish alone and it is difficult to predict an exact figure. Even uncontested elections will involve some costs being recharged, as a guideline, uncontested election costs will be in the region of £100.

Contested elections for the average sized parish should be at least £1,500 but this is only an estimate and will depend on the actual cost of ballot paper, postal vote and counting sheet printing. Large parishes, warded Parishes and Town Councils will incur greater costs.
