MEETING MINUTES

1. Minute 014/021: Meet & Greet.
 1. Steve Collins (Kilve Chair) welcomed Holford Parish Council.

2. Minute 015/021: Quiet Lanes Community SpeedWatch.
 - EC informed Kilve PC that the Holford Traffic Monitoring Group/ Road Safety Group is now going it alone at their own request. Holford Parish Council (HPC) to discuss involvement and way forward at the next Parish meeting.
EC requested formal issues to be shared with HPC.
 - SC informed a carefully researched, comprehensive report would make a strong case for a Quiet Lanes scheme for Holford. Holford would want to co-operate fully with Kilve because a strong case from two adjoining villages would be extremely convincing. Kilve Cllr. Greg offered to share the framework prepared for a Kilve case for a Quiet Lanes scheme.
